**Requirements** All entrants must wear helmets. Riders will be required to sign a waiver and release at the event. Valid motorcycle driver's license, valid license plate & registration, current proof of insurance, spark arrestor/muffler, headlight and taillight are required. All entrants must have a valid AMA card. *NO EXCEPTIONS WILL BE MADE.* AMA membership is available at sign-up.

**Course Information** This event is big bike, adventure riding and dual sport friendly! 100 miles of scenic Susquehanna County dirt roads with alternate trails with fun in mind. The mileage between gas station stops around 40-45 miles.
